Governor Bill Richardson to Propose Public Safety Initiatives

SANTA FE- Governor Bill Richardson will outline his 2005 legislative proposals to continue his fight to crack down on DWI and to protect New Mexicans. The proposal will include specific recommendations relating to DWI, Victim's Rights, Gang Violence, and Judicial Standards.

Governor Richardson will preview his Public Safety Initiatives during trips to Farmington, Gallup, Deming, Las Cruces, Alamogordo, Hobbs and Albuquerque on Wednesday and Thursday of this week.
