## **EXECUTIVE ORDER 2019-009**

## DECLARING A STATE DISASTER DUE TO SEVERE WIND EVENTS, TORNADOES, HAIL DAMAGE AND ELECTRIC POWER OUTAGES

WHEREAS, The National Weather Service identified an unusually powerful low pressure wind event with accompanying blizzard conditions and potential for tornadoes likely to impact portions of the State of New Mexico from March 12, 2019 through March 14, 2019; and,

**WHEREAS**, on March 12, 2019 through 14, 2019, tornadoes and extreme winds struck several impacted areas statewide; and,

WHEREAS, damage occurred to public infrastructure, electric cooperatives, railroad freight trains, public property and highway trucking throughout the affected area; damage assessments are on-going; and,

WHEREAS, prior to receiving receive State Disaster Assistance, Local Disaster Resolutions must declare that all locally available public and private resources and forces available to mitigate and alleviate the damage were deemed insufficient to cope with the resulting situation, initiate repairs and meet restoration requirements; such Resolutions must request aid, assistance, relief, and funds from the State of New Mexico and the Government of the United States if applicable; and affected counties and municipalities will submit their Disaster Resolutions as they become available; and,

WHEREAS, this emergency requires prompt governmental action to protect public peace, health, and safety and to preserve the lives and property of the people of the State of New Mexico; and,

WHEREAS, this emergency is of such magnitude as to be beyond local control and requires the resources of the State to avoid or minimize economic or physical harm and to take action necessary to protect the public health, safety, and welfare.

NOW, THEREFORE, I, Michelle Lujan Grisham, Governor of the State of New Mexico, by virtue of the authority vested in me by the Constitution and Laws of the State of New Mexico, do hereby declare a state of emergency to exist in the in the State of New Mexico due to the effects of the March 12, 2019 through March 14, 2019 wind storm.

I DIRECT the Department of Finance and Administration to make available emergency financial resources in an amount not to exceed seven-hundred and fifty-thousand (\$750,000) to the Department of Homeland Security and Emergency Management in accordance with NMSA 1978, §§ 12-11-23 through 12-11-25. The funds shall be expended for actions taken to avoid and minimize economic and physical harm; to protect the public health, safety, and welfare; and to respond to, recover from, and mitigate damage from this or any other anticipated event and shall be paid out only in an amount specified by warrants drawn by the Secretary of the Department of Finance and Administration upon vouchers approved by the Governor or the Governor's designee.

I FURTHER DIRECT the Department of Homeland Security and Emergency

Management to coordinate all requests for assistance and responses to such requests

under the authority of and as determined by the Governor and her Authorized Representative and to request such aid and assistance from the Federal Emergency Management Agency (FEMA) as may be appropriate.

I FURTHER DIRECT the Adjutant General to order into service any elements of the New Mexico National Guard as are or may be needed to provide military support to civil authorities as needed for this emergency. This action is pursuant to and in accordance with NMSA 1978, §§ 20-1-1 through 20-1-8, NMSA 1978, §§ 20-2-1 through 20-2-8, and NMSA 1978, §§ 20-4-1 through 20-4-14. Such emergency assistance shall be provided during the period of need at the discretion of the Governor's Authorized Representative.

I FURTHER DIRECT all Cabinet Departments and agencies of the State of New Mexico to provide any assistance that may be required by the Department of Homeland Security and Emergency Management or by the State Emergency Operations Center under the authority of the Governor's Authorized Representative

THIS ORDER supersedes any other previous orders, proclamations, or directives in conflict. This Executive Order shall take effect immediately and shall remain in effect until such time as the Governor rescinds it.
