SENATE EXECUTIVE MESSAGE NO. 48

Dear President Pro Tempore Stewart and Members of the Senate:

I am pleased to sign Senate Finance Committee Substitute for Senate Bill 213, with emergency clause. This legislation makes renewed use of public funds that have yet to be expended and were authorized in previous years from various funds. It is vital that we deploy public funds to benefit New Mexico's children, families, and communities. This legislation furthers that important end.

Accordingly, I this day SIGN and RETURN:

SENATE FINANCE COMMITTEE SUBSTITUTE FOR SENATE BILL 213, with emergency clause, enacted during the Fifty-Fifth Legislature, Second Session, 2022, except the following item or items, part or parts, which I hereby veto pursuant to the authority granted me in Article IV, Section 22 of the New Mexico Constitution:

On page 11, I have vetoed lines 14 through 21. This language was reauthorizing the extension of time to June 30, 2024, and the reversion date was already June 30, 2024.

On page 14, I have vetoed line 5, beginning with the word "The", through the "." on line 6. This removes the time of expenditure extension through 2024. The time of expenditure for the original project was through fiscal year 2025.

On page 14, I have vetoed lines 23 through page 15, line 4. This project has a remaining project balance of \$3,987.06.

On page 16, I have vetoed lines 16 through 25. This project has a remaining project balance of \$2,675.84.

On page 19, I have vetoed line 21 through page 20, line 4. This project has a remaining project balance of \$2,973.02.

On page 20, I have vetoed line 25 through page 21, line 10. This project was overfunded, and the balance has already been reverted.

On page 28, I have vetoed line 8, beginning with the word "The", through the "." on line 9. This removes the time of expenditure extension through 2024. The time of expenditure for the original project was through fiscal year 2025.

On page 37, I have vetoed lines 5 through 13. This language was reauthorizing the extension of time to June 30, 2024, and the reversion date was already June 30, 2024.

On page 37, I have vetoed lines 14 through 22. This language was reauthorizing the extension of time to June 30, 2024, and the reversion date was already June 30, 2024.

On page 38, I have vetoed line 19 through page 39, line 1. This language was reauthorizing the extension of time to June 30, 2024, and the reversion date was already June 30, 2024.


On page 42, I have vetoed lines 4 through 10. The original appropriation was fully expended leaving no balance to reauthorize.

On page 45, I have vetoed line 22 through page 46, line 4. The original appropriation was fully expended leaving no balance to reauthorize.

On page 49, I have vetoed lines 8 through 19. The Nambe Pueblo Governor sent a letter to veto this reauthorization.


On page 59, line 21, I have vetoed the words "to the department of transportation". This appropriation should stay with the Local Government Division. The purpose was to change the language, not the agency.
