EXECUTIVE ORDER 2022-021

DECLARING AN EMERGENCY IN MORA COUNTY DUE TO THE COOKS AND CALF FIRES AND AUTHORIZING EMERGENCY FUNDS FOR THE DEPARTMENT OF HOMELAND SECURITY AND EMERGENCY MANAGEMENT

WHEREAS, Mora County was severely impacted by the Cooks Fire that began on Sunday, April 17, 2022, and the Calf Fire that began on Tuesday, April 19, 2022;

WHEREAS, the Cooks Fire sustained winds of over forty-five (45) miles per hour with gusts of up to seventy (70) miles per hour, and thereby spread rapidly, which has resulted in undue suffering and hardship and threatens the safety, health, welfare, and well-being of the citizens and local economy of Mora County;

WHEREAS, the Calf Fire also sustained winds of over forty-five (45) miles per hour with gusts of up to seventy (70) miles per hour, and thereby spread across 3,000 acres, which has resulted in undue suffering and hardship and threatens the safety, health, welfare, and well-being of the citizens and local economy of Mora County;

WHEREAS, the Cooks and Calf Fires prompted Mora County to issue local disaster declarations;

WHEREAS, the disaster declarations issued by Mora County noted that all local resources available have been insufficient to cope with the resulting situation and request aid, assistance, relief programs, and funding from the State of New Mexico;

WHEREAS, these disasters requires immediate action to protect public peace, health, and safety; and

WHEREAS, these disasters are of such magnitude as to be beyond local control and requires the resources of the State of New Mexico to minimize economic or physical harm and to take actions necessary to protect the public health, safety, and welfare.

NOW, THEREFORE, I, Michelle Lujan Grisham, Governor of the State of New Mexico, by virtue of the authority vested in me by the Constitution and the laws of the State of New Mexico do hereby **DECLARE** a state of emergency to exist in Mora County due to the Cooks and Calf Fires that began on Sunday, April 17, 2022, and Tuesday, April 19, 2022, respectively, and **ORDER** and **DIRECT** as follows:

- 1. The Department of Finance and Administration shall make available emergency financial resources in an amount not to exceed seven hundred and fifty thousand dollars (\$750,000.00) to the Department of Homeland Security and Emergency Management in accordance with NMSA 1978, Sections 12-11-23 to -25, and NMSA 1978, Sections 12-10-14 to -15. The funds shall be expended for the resources and services necessary to avoid or minimize economic or physical harm until the situation becomes stabilized; on a temporary, emergency basis for lodging, sheltering, health care, food, any transportation or shipping necessary to protect lives or public property; or for any other action necessary to protect the public health, safety, welfare, and property. The funds shall be expended in accordance with the policy and procedures of the Department of Homeland Security and Emergency Management, as approved by the Governor or the Governor's Authorized Representative.
- 2. The Department of Homeland Security and Emergency Management shall coordinate all requests for assistance and responses to such requests under the authority of and as determined by the Governor and her Authorized Representative. In addition to such other eligibility criteria as may be established by the Governor and her Authorized Representative, applicants requesting financial assistance from the State for necessary action taken in response to Executive Order 2022-021

the emergency shall be required to demonstrate that the cost of the necessary action exceeds their available resources, as determined based upon criteria developed in conjunction with the State agencies (if any) with financial and budgetary oversight responsibilities for the applicant.

- 3. The Adjutant General shall order into service any elements of the New Mexico National Guard as are or may be needed to provide military support to civil authorities as needed for this emergency. This action is pursuant to and in accordance with NMSA 1978, Sections 20-1-1 to -8, NMSA 1978, Sections 20-2-1 to -8, and NMSA 1978, Sections 20-4-1 to -14. Such emergency assistance shall be provided during the period of need at the discretion of the Governor's Authorized Representative.
- 4. All Cabinet Departments and agencies under gubernatorial control shall provide any assistance that may be required by the Department of Homeland Security and Emergency Management or by the State Emergency Operations Center under the authority of the Governor's Authorized Representative.

I FURTHER ORDER and DIRECT as follows:

- 1. This Order supersedes any previous orders, proclamations, or directives to the extent they are in conflict.
- 2. This Order shall take effect immediately and shall remain in effect until renewed, modified, or rescinded.
