## SENATE EXECUTIVE MESSAGE NO. 29

President Pro Tempore Stewart and Members of the Senate:

I am pleased to sign SENATE FINANCE COMMITTEE SUBSTITUTE FOR SENATE BILL 425, with emergency clause, with certificate of correction, with various line-item vetoes made pursuant to Article IV, Section 22 of the New Mexico Constitution. This legislation renews the use of public funds that have yet to be expended and were authorized in previous years from various funds. We must deploy these resources to benefit New Mexico's children, families, and communities, and this legislation advances that vital goal.

Accordingly, I SIGN and RETURN:

SENATE FINANCE COMMITTEE SUBSTITUTE FOR SENATE BILL 425, with emergency clause, with certificate of correction, enacted during the Fifty-Seventh Legislature, First Session, 2025, except the following item or items, part or parts, which I hereby veto pursuant to the authority granted to me under Article IV, Section 22 of the New Mexico Constitution:

I have vetoed line 25 on page 18 and lines 1 through 8 on page 19. This appropriation has not been spent to date.

I have vetoed lines 14 through 24 on page 22. This appropriation has not been spent to date.

I have vetoed the words “for city council district” on page 23, line 13, and the number “3” on page 23, line 14. The vetoed language removes the project owner’s discretion to choose the best location for the project.

I have vetoed lines 7 through 18 on page 25. The available balance is less than five percent (5%) of the original appropriation.

I have vetoed lines 19 through 25 on page 25 and lines 1 through 2 on page 26. This appropriation’s current reversion date is June 30, 2027.

I have vetoed lines 3 through 10 on page 26. This appropriation has not been spent to date.

I have vetoed the words and punctuation “--SEVERANCE TAX BONDS” on page 26, line 21. The appropriation was made from the General Fund.

I have vetoed lines 1 through 7 on page 157. This appropriation has not been spent to date.


