HOUSE EXECUTIVE MESSAGE NO. 99

Speaker Martínez and Members of the House:

HOUSE TAXATION AND REVENUE COMMITTEE SUBSTITUTE FOR HOUSE BILL 332, as amended, without emergency clause, renews the use of public funds that have yet to be expended and were authorized in previous years from various funds. While I support many of these reauthorizations, I hesitate to reauthorize appropriations that have not been promptly put to use. Such delays undermine the fundamental purpose of these investments, which is to direct resources toward programs that deliver timely and meaningful benefits to New Mexicans. When funds remain idle beyond their intended period of use, it becomes necessary to reassess whether reauthorization is the most responsible course of action. For this reason, I have vetoed certain appropriations that have seen little or no expenditure. This approach ensures that state dollars are managed prudently and redirected, when appropriate, to initiatives that are ready to move forward and able to make an immediate impact for the State's children, families, and communities. I have also vetoed certain provisions that either prevent the agency from using the full appropriation to implement the legislative purpose, reauthorize ineligible appropriations, or change the purpose of the original appropriation.

Accordingly, I SIGN and RETURN:

HOUSE TAXATION AND REVENUE COMMITTEE SUBSTITUTE FOR HOUSE BILL 332, as amended, without emergency clause, enacted during the Fifty-Seventh Legislature, Second Session, 2026, except the following item or items, part or parts, which I hereby veto pursuant to the authority granted me under Article IV, Section 22 of the New Mexico Constitution:

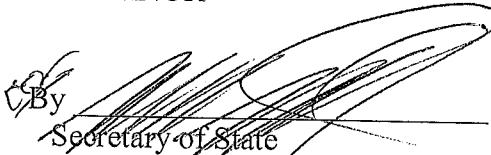

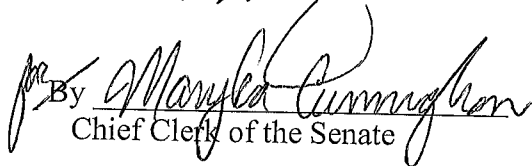
